WAYS OF GIVING

Examples of the types of gifts that can help to support the Portage County Public Library:

- A bequest in your will or living trust to the Portage County Public Library Foundation
- A gift of securities (including stocks and bonds) or property
- Beneficiary designations of life insurance or retirement plan proceeds
- Gifts with retained income for yourself or others

All contributions to the Foundation are tax-deductible to the extent permitted by law.
